## SATISFACTORY ACADEMIC PROGRESS APPEAL

Those receiving federal student aid at the college are required to make *Satisfactory Academic Progress* toward earning a degree or aid-eligible certificate. Satisfactory Academic Progress is defined as:

- Earning at least a 2.0 (C) cumulative grade average, AND
- Passing at least 67% of cumulative attempted credit hours, AND
- Graduating within 150% of the minimum number of credit hours required to complete graduation requirements.

Because you are not currently meeting all *Satisfactory Academic Progress* requirements, you are not eligible for most forms of financial aid at the college. However, you may appeal your ineligibility; use this form to do so.

1. Print in dark ink or type.
2. Be clear, specific, and to the point. DO NOT attach additional pages, they will not be read.
3. Submit supplemental documentation such as doctors' reports, obituaries, etc. which substantiate your situation. Submit copies—not originals—of supporting documents. No materials will be returned to you.
4. You are required to meet with a Success Coach in the Student Success Center to complete Part II of your appeal. The success coach will submit both parts of the appeal to the Financial aid Office.
5. A committee of NC State faculty and administrators will review your appeal and render a decision. The committee's decision is final and may not be contested.
