	Attend CCP Info Meeting at high school & meet with your school counselor to discuss interest in CCP.
	Submit your Intent to Participate Form by April 1 every year.
	Public school students, submit form to school counselor.
	Non-public and homeschool students, submit form electronically with annual CCP funding application at //highered.ohio.gov/.

	1. Apply to North Central State College for CCP by the semester deadline: ncstatecollege.edu/ccp .
	 Apr. 1 for Summer Term (May) Jun. 1 for Fall Term (Aug.) Dec. 1 for Spring Term (Jan) *Use a non-school email address to apply. Your school email will block emails sent from NCSC and you will miss essential info.
	2. Request Transcript be sent to NCSC.
	3. Establish CCP Eligibility & College Admission: Ensure NCSC receives the required docs to review.
	The CCP Permission Slip and Student Questionnaire are Supplemental Items to complete in the NCSC Application Portal.

	4. Watch email: as requirements are met, you are notified by email about CCP Admission and final steps to register.

New CCP Students: Dec 5 Continuing CCP Students: Dec 12	Spring Registration Deadline (Courses at NCSC or online) Your school may set a different deadline for CCP courses held at your HS.			

All items must be received or completed by the deadlines. Failure to do so will result in CCP registration being delayed until the next eligible term.
