## UNUSUAL ENROLLMENT HISTORY WORKSHEET

- The FAO will review your material and may:
  - Determine that your UEH is justifiable and resume the processing of your application for aid.
  - Require additional documentation or processes.
  - Determine that your UEH is not justifiable and deny you federal aid at NC State.
- No aid will be awarded prior to the completion of this review. You are responsible for all charges at the college until sufficient aid eligibility has been established.
