- J. Course Description: This is a practicum experience course and is a continuation of RESP 2490, Practicum IV. This rotation is 36 hours per week for 5 weeks (180 total hours). A faculty advisor is assigned to the student and they work together to set up the student's practicum experience. The student will be assigned to a health care facility to work under the supervision of a licensed respiratory care professional. The student may be assigned to various areas of respiratory care which may focus on therapeutics, critical care, emergency medicine, diagnostic, and rehabilitation. The faculty advisor will regularly visit and collaborate with the student's employer supervisor to provide feedback and evaluations to the student.

**IV. Class Attendance and Homework Make-Up Policy:**

1. If a student misses TWENTY percent (20%) of the clinical time for whatever reason, excused or unexcused, the student CAN NOT meet the objectives of the course and the highest grade the student will receive is a D+. Defined as 36 hours per week for RESP 2590.
2. Attendance penalty guidelines for excused absence:
  - a. first 4 hours no penalty, b.
  - b. each additional 4 hours missed thereafter will be -3% deducted from the student's final grade.
  - c. Penalty for unexcused absence: 1% drop in grade for each hour or portion of an hour of unexcused absence.
  - d. Missed hours will accumulate toward the 20% missed clinical time.
3. If a student misses clinical time, the student is required to make this up. Absences MUST be communicated with the
4. department manager and DCE. The student is responsible for scheduling a make-up date and MUST be communicated to the DCE.
5. Students who do not attend classes may be administratively withdrawn from those classes. However, failure to attend classes does not constitute withdrawal, and students are expected to process a formal withdrawal through the Student Records Office

**V. Classroom Expectations:**

1. You are expected to arrive at the clinical location and report to the Respiratory Department (or designated meeting location) prior to the scheduled start time. If you are going to be late or absent you are to contact the manager and the DCE ASAP. Failure to do so will result in an Unexcused Absence.
2. You are required to wear NCSC Respiratory Student scrubs and have necessary equipment (stethoscope, scissors, pen, etc.) with you.
3. This is your final clinical experience for the Respiratory Care Program, as such you are to always perform in a professional manner while at your clinical facility. Failure to do so will result in a reduction of your grade based upon the evaluation from the Respiratory Manager or Practicum Facilitator
